# **OPEIU Local 8 Employees Retirement Plan**

This important information is for Local 8 members who currently participate in the OPEIU 401(k) Plan <u>OR</u> who are eligible to participate but not enrolled. Transamerica is the company that manages Plan investments. Benefit Administration Company (BAC) administers the Plan.

#### HOW TO ENROLL IN THE OPEIU LOCAL 8 EMPLOYEES RETIREMENT PLAN:

Complete the Enrollment and Beneficiary Designation Forms found in the Transamerica Enrollment Booklet.

To request a Booklet, contact your Employer, your Union Representative or Benefit Administration Company (see contact information below) and an Enrollment Booklet will be sent to you. You have a choice of investments. The Booklet will guide you through the process.

Return the completed Enrollment and Beneficiary Designation Forms to your employer for processing.

Once you enroll in the Retirement Plan, your contributions will automatically be sent to Transamerica each pay period for investing into your retirement account. You will receive quarterly account statements reflecting the savings you have accumulated, and you will be able to access your retirement account information through Transamerica at any time (see information below).

  - In addition to providing access to your Retirement Plan account information, the Transamerica Website is loaded with useful information, helpful tips and interactive tools, all designed to help you discover, build and manage your Plan account.
- √ Via the Telephone call (800) 401-8726
  - The Transamerica automated telephone system offers you direct access to your Plan account information. You can access the system 24 hours a day seven days a week.

- 5. Click on any investment choice name to view the investment Fact Sheet for that investment
