## Action Needed by Trios Workers

Currently Management is still not proposing cost of living increases that are comparable to what the Nurses are receiving. This is not acceptable. We need to send a message to the Trios Board that we are just as valuable.

We have also posted Petitions that you can sign on the Union Boards in the Break Rooms on 2N and 3N and on the Union Board near Service Elevators outside the Kitchen. **Please make sure you sign the petition by noon Wednesday, May 11.**

Also, plan on attending the Trios Board Meeting **Thursday, May 12 at 5 pm**, Southridge Care Center Executive Conference Room. Let's send a strong message that WE DESERVE more. And your presence at the board meeting can show them this is a priority for the workers at TRIOS.
