

Home Care Works Because We Do!



Local 8 Home Care Worker members from Sea Mar, Fremont Homecare, Oly-CAP and Visiting Nurse Services met on December 7 at our Annual Home Care Legislative Breakfast to talk about taking our message to Olympia this year. Local 8 MSW Student Intern, Heather Golden, helped to organize the event.

Home Care Workers are the backbone of long-term care services. They provide heavy personal care and other tasks vital to our elderly and disabled citizens, saving our state millions of dollars every year by enabling frail elderly and disabled individuals to stay at home where they prefer to be. However, Home Care remains one of the lowest paid jobs in the state.

This year we'll be going in small groups to talk one on one with our legislators. Our Legislative Proposal this year includes:

- **Increase Compensation for Home Care Workers** to provide a decent standard of living.
- **Increase Agency Reimbursement Rate** to reflect the rapidly increasing costs incurred by agencies struggling to provide quality care.
- Oppose Nurse Delegation Legislation unless Home Care Workers receive increased compensation for the additional responsibilities they will be asked to perform.
- **Protect Medical Benefits** for Home Care Workers by making sure funding continues and accommodates rising insurance costs.
- **Support Tax Alternatives** to increase state revenue.

PEMC'S OPERATIONAL IMPROVEMENT PLAN


When our members received letters about a proposed
