Members Approve Historic Changes

With the historic task of redesigning our representation structure, nearly 40 members worked hard over March 5 and 6 to hammer out a plan to recommend to Local 8 members. At the March 23 General Membership Meeting, members unanimously approved recommendations from the two Workgroups as follows:

The Statewide Representation Workgroup, facilitated by Business Manager Suzanne Mode, had the goal to expand the Executive Board to allow for greater participation from members living outside of the King County area. The Workgroup recommended adding four Regional Executive Board Members and Alternates. Two would be from Snohomish County north, one from Pierce County South and West and one from East of the Cascades. Members who live in the particular region will nominate and vote for their Regional Executive Board Representative(s). A special election will be held for these positions in early 2006 for a one-year term. All officers will be up for election in 2007. The recommendations also call for some mandatory on-site attendance with calling-in for remaining meetings. (Cont'd. on page 3)
