Historic Local 8 Bylaws Changes

In March, nearly 40 members met in Tokeland, Washington to chart out a plan for expanding our Executive Board to ensure greater participation from members living outside of King County. The Statewide Representation Workgroup put forth recommendations for this restructuring which were approved by the General Membership at our March Membership Meeting.

On April 20th the Bylaws Committee met to draft changes to the Bylaws. Many thanks to Bylaws Committee Members: Kathi Scott, Craig Davis, Kellie McGuire, Angela Boehlke, Colleen Shelton, Suzanne Mode and Cindy Schu. The Committee drafted significant changes to the Bylaws which will be presented to the Local 8 Executive Board on May 11.

The first reading of the proposed changes will take place at the May 25 Membership Meeting. The second reading will take place at the June 22 Membership Meeting at which time there will be discussion and an opportunity to make changes or amendments to the Bylaws. The Membership will also vote on the Bylaws changes at the June Meeting.

The entire Bylaws changes will be available at the May Membership Meeting. In summary, here are the major proposed changes:

- The Executive Board shall be expanded to include four (4) Regional Executive Board members and four (4) Alternates. Regional Executive Board members will be required to attend and will be reimbursed for attending in-person the January Executive Board meeting, the June General Membership Meeting and, in General Election years, the March Membership Meeting. (Other Executive Board meetings will be attended via teleconference.)
- Two Regional positions will be elected from the North, one position from the South/West and one position from the East.
- Only those members who reside in the same geographic areas as the Regional Executive Board members will be allowed to nominate and vote on the Regional positions.
- A special Mid-Term Mail Ballot Election will be held in early 2006 for the new positions. Regular General Elections will take place for all officers and Executive Board positions in 2007.
- In addition to these proposed changes, the Committee is recommending changes to Article 17 "Strikes" and Article 18 "Rules of Order."
- A complete report on the proposed changes to the Bylaws will be available at the May Membership Meeting.
