It was my pleasure to represent Local 8 at the Asian Pacific American Labor Alliance (APALA) Organizing Institute in Los Angeles on May 2-4. These three days of intense training included labor history with an Asian Pacific Islander perspective, a solidarity action with the United Steel Workers, principles of organizing, and finally graduation.

I want to truly thank you for the opportunity to learn the principles of organizing. Whether internal, external, or community organizing, I am confident of the skills needed to effectively change people's lives through growing the Union. I never knew that as a Korean-American I come out of such a rich history of labor activism and leadership. Many times throughout this training I felt the hot tears of injustice flow down my face as I understood the struggles that my forefathers faced on my behalf.

This training focused on learning the principles of organizing through role plays. In addition, we were taught the particulars of organizing API folks (Asian Pacific Islanders) or immigrants in general. We learned that there are profound issues that immigrants or undocumented workers face.

Because of the intense and transformational nature of these three days, many of the participants left with the sentiment that we were collectively a new generation for the labor movement.

My pledge to you is that I will continue the good work that has been wrought within me. I will work with the goal of reporting back to the body and educating you all about the needs of your API brothers and sisters. From the bottom of my heart, I wanted to extend to you a "deep bow" of gratitude.

### **JOHN McCAIN: What You Should Know**

As union members, regardless of our political party or affiliations, we need to know how candidates stand on working family issues. John McCain calls himself a "maverick" and a "straight talker" but what does he really stand for? Here's a look:

• Will Increase Health Care Costs and Reduce Access. McCain's plan undermines existing employer based health care and pushes workers into the private market to fight big insurance companies on their own. He will make health care premiums part of taxable income, essentially creating a new tax for working families. His plan will reduce benefits, increase costs and leave many with no health care at all. (*CBPP*, 4/5/06; *Health08.org, Forum*, 10/31/07; Los Angeles Times, 11/20/07; Commonwealth Fund, 6/2005)

- More of the Same. McCain supported President Bush's positions 95 percent of the time in 2007 and an average of 89 percent over Bush's two terms in office. (Congressional Quarterly Voting Study, 110th Congress)
- **Opposes Our Right to Bargain.** McCain voted against the Employee Free Choice Act, which would level the playing field for workers trying to form unions, and for a national Right-to-Work-for-Less law that would attempt to eliminate unions altogether. (*H.R. 800, Vote #227, 6/26/07; S. 1788, Vote #188, 7/10/96*)
- Jeopardized Our Retirement Security. McCain supports privatizing Social Security, putting our retirement at risk, and raising the Medicare eligibility age. (SCR 83, Vote #68, 3/16/06; SCR 18, Vote #49, 3/15/05; S. Amdt.144 to SCR 18, Vote #47, 3/15/05; SCR 86, Vote #56, 4/1/98; SCR 86, Vote #77, 4/1/98; S. 947, Vote #112, S. Amdt. 445, Vote #115, 6/25/97)

Too many absences? Serious health condition? For employees who work for an employer with greater than 50 people, the federal Family and Medical Leave Act or the Washington State Family Care Act may benefit you. These laws provide protected leave of twelve weeks to care for serious health conditions for yourself and/or your family members. Your leave can be set up to be used intermittently or for a consecutive twelve weeks. You may need to provide certification from the provider and it is your responsibility to keep your employer updated. Check with your Union Representative to see if you can protect your absences from work with one of these laws.
