# Union Power for La Clínica Workers

It's been over a year since their contract has expired, but the workers at La Clínica (now called Tri-Cities Community Health-TCCH) continue to stand up to an employer bent on taking away nearly every protection currently in their Union Contract. TCCH, a community and migrant health center dependent on mostly state dollars, has employed a high priced attorney who

is a partner at a multinational law firm.





After months of wasting valuable resources on union busting, TCCH is now proposing layoffs. The Bargaining Team has offered to make economic concessions, but management persists in driving the organization further afield. Last month workers organized an informational picket to gather support from the community who rely on the services provided by TCCH. Watch for more street action in the future.

# No Time for Sitting On the Sidelines

Unions stand for preserving the right to join freely with our co-workers to improve workplace standards through collective bargaining, providing family wage jobs and a safety net for those without resources and creating a framework for a fair and equitable society. Contrast these ideals with a nation that tolerates a 23% increase of CEO pay in 2010 with an average salary of \$11.5 million, where 400 U.S. families have more wealth than 155 million Americans combined

and income inequality that grows daily.

The continuous battle for a more economically and socially just country has escalated to appalling heights. The budget fight in Wisconsin symbolizes the national debate over the power and relevance of Unions. Governor Scott Walker and others want us to believe Unions are greedy and irrelevant. They not only want hefty concessions from union employees, they also want to squash our rights and decimate our collective

power. Unfortunately Wisconsin is not alone in this demolition. Local 8 members at the Washington State Ferries, home care agencies, housing authorities, King County and community health centers all face threatened financial security.

But as the great folk singer and activist Pete Seeger observed recently, "Maybe the Republican governor, he's done us a favor by bringing the problem to national attention. It shows the whole country how much we need unions. We may end up thanking him."

There's no choice but to push forward forcefully and urgently. We can't sit on the sidelines waiting for better times. We must organize so workers have the protection of a union contract like new members at Sea Mar's Cannon House in Seattle and Group Health Cooperative in eastern Washington/northern Idaho. We must mobilize for fair contracts that preserve workplace standards like members at Tri-Cities Community Health (formally La Clinica) are doing to push back attempts to gut their contract. We must join with fellow union members in visible protests like the Week of Action rallies where thousands gathered to show "WE ARE ONE".

Maintaining a strong union that can weather these difficult financial times and stand up to emboldened employers takes an active membership. Fortunately, with our new structure more and more Local 8 members ARE participating. As we go into the second year of our statewide governance model, nearly 100 activists attended our third statewide Assembly in January. Members from all over the State met for the day and decided the policies and priorities of our Union. And, with the election of Business Manager

**Suzanne Mode** as an OPEIU Vice-President, we have a direct voice to our International. For the first time in Local 8's history, we have a Hardship Fund for our Members in need. Our Diversity Committee, Shop Steward/ Education Committee, Chapter/ Assembly Committee and Political Action Committee have all seen increased participation.

Now is not the time to despair and sit on the sidelines. We must stand up for what we believe in by actively protesting our government's wayward direction and/or by participating in our employee organization to build a powerful workplace voice.
