Management Proposes their Best and Final Wage Offer -- Time to Vote!

Online Voting Instructions:

Online voting will be open starting June 29th at 9:00 am and continue through July 2nd at 3:00 pm. <u>Vote here</u>.

Rules for Online Voting: You must be an OPEIU member in good standing. You can only vote one time. All votes must be submitted no later than 3:00 pm on July 2^{nd} . Any votes cast after 3:00 pm on July 2^{nd} will not be counted.

Here is <u>a link to the full document</u> that shows the tentative changes you will be voting on. New language to be added is <u>underlined</u> and in <u>bold</u>, language we are proposing to delete is struck through.

Our Bargaining Team (Dennis Johnson, Front Desk Resident Assistant, Frye, Erin Adamson and Diane Arnold, Union Representatives) met with management on May 28th to hear their response to our Union Counter wage opener proposal of a two percent across-the-board wage increase retro to January 1, 2020. Management stated that they cannot pay a COLA for 2020 due to financial uncertainty during the pandemic but will continue seniority increases for those Union employees at the top of their range/skill steps or anniversary skill steps for 2020 if eligible. Management also stated that LIHI non-union staff will not receive any pay increases for 2020.

Management re-stated that they cannot afford an acrossthe-board cost of living increase at this time because of the following:

- Collection of rents were down significantly in April and May,
- Concerns for the Governor's no-eviction ordinance through

Our LIHI Union members must decide to accept or reject the employer's best and final offer.

If approved, our Union staff will receive their anniversary increases if eligible and our Union bargaining team will begin negotiating wages for January 2021 in October of 2020.

If rejected, our Union Bargaining Team will go back to the table to

- August 1, 2020 which potentially will lead to further rent loses,
- Loss of revenue because of unexpected retail space vacancies,
- Need to maintain a balanced budget and are concerned that despite the fact they are opening more programs and hiring staff, they want to avoid laying staff off or furloughing employees,
- Cancellation of their annual fall auction fund raiser which supplement Urban Rest Stops, Tiny Villages and other program needs.

continue negotiating with management with no guarantees that the employer will offer any wage increases for 2020 including the seniority or anniversary skill step increases. A "no" vote also means that Union members voting "no" will be expected to make a commitment to participate in visible organized Union actions against the employer such as wearing a button during work hours with a message to management, signing a petition to be delivered to the LIHI leadership team and board of directors or other similar public actions to show our solidarity.

Many LIHI bargaining unit members wonder how LIHI can purchase property and break ground on the new Othello Park Apartments. Management's response is that they purchased the property with low interest WSHFC loans and that the financing for the Othello project was set before COVID-19.
