Payment issues

OPEIU Local 8 members work hard every day for Kaiser Permanente. KP has a legal obligation to pay us for that work accurately and on time. All of us are aware of the delays and errors in payment that members have experienced for the last two pay periods. This is unacceptable. OPEIU Local 8 has filed a grievance in order to ensure all issues are resolved in a timely manner, and that everyone is paid correctly as well as credited with the correct benefit hours. We have also been pushing KP for better communication surrounding this issue. If you notice any discrepancy in your pay and/or benefit accruals, feel free to contact Shauna Straight ShaunaL.Straight@kp.org and she will escalate your concern and attempt to resolve it.

In addition to the pay issues, there are other HR Connect concerns. Therefore, we are approaching management as a group effort with the other unions at KP. OPEIU Local 8, SEIU 1199NW and UFCW Local 21 are working together to take on this new payroll system that is causing a real hardship for union members. Extra Work Available at Vaccine Clinics

You should be receiving emails through district communications where you can sign up for additional shifts for non-clinical duties at the vaccine clinics KP is offering. This is just the start of a ramping up of COVID-19 vaccinations, and there will be plenty of additional work to do now and in the immediate future.
