Shop Steward Highlight: Alan Wolfson

Alan Wolfson was several years into his career at the King County Department of Assessments when he and his coworkers decided they needed a union. They interviewed several unions and decided OPEIU Local 8 was the one for them. When it was time to pick a Shop Steward, Alan's coworkers decided he would be good for the role. As a Shop Steward, Alan felt



he needed to be informed about his union, so he started attending the monthly meetings and over time took on more and more roles. "If you don't get involved with your union, you're not going to reap the full benefits," Alan said. "It can be hard to navigate at first, but if you go to the meetings, you can learn how your union works on the local level and then go from there."

When Alan was asked to be the local's Chairman for Elections he accepted, and the first election he conducted was quite contentious and turned out to be on the day of the Nisqually earthquake in 2001. They still held the election. Alan also became a delegate to his local Central Labor Council (CLC) in ML King County, served on the Bargaining Team for every contract after the first, and the Joint Labor Management with the Coalition of Unions at King County. Fellow Local 8 members who have attended the General Assemblies may remember him for his role as Auctioneer many times at the PAC Auction during the social hour. More recently, Alan decided to step back from some of these roles to make space for other members who may want to get involved. "I think if I can turn the reigns over on one thing or another, someone else can learn," he said.

After 30 years at the Department of Assessments working with many different Assessors and Deputy Assessors, Alan retired in June 2021. He hadn't originally planned it that way, but he contracted Covid-19 in March 2020 before anyone knew what it was and has suffered with long-hauler symptoms since. Retirement will enable him to focus on his recovery. "Get vaccinated if you haven't. Don't hesitate to wear a mask if you feel like you should," he said. "You don't want to go through what I went through with this illness."

Reflecting on his time and various roles as an active union member, Alan remembered a few other highlights such as having guest speakers like then-Representative Inslee at union events, and the ML King County CLC Labor Day Picnics at Woodland Park Zoo. "For anyone with an interest in being heard, it's always nice to be active in these organizations and take advantage of the opportunity," he said. At these events, he got to chat with elected officials from all different levels, from city council members to King County Executive Dow Constantine and Senator Patty Murray.

We wish Alan the very best in his retirement and are glad he's keeping his OPEIU membership as a Retiree.

Did you know? Washington Cares Fund

Washington State is the first in the nation to develop a way to make long-term care affordable for all workers in the state as we age. The Long-Term Services and Supports Trust Program (referred to as the "LTSS Program" or "WA Cares Fund") is a new fund which will provide access to long-term care when we need it.

The LTSS Program will be funded by premium assessments collected by employers through payroll deduction. Starting January 1, 2022, all Washington employee wages (those employees who work in Washington, receive wages reported on a Form W-2, and work at least 500 hours per year) are subject to a 0.58% premium assessment (for example, \$0.58 premium assessment on every \$100 of eligible wages).

Starting January 1, 2025, proceeds of this premium assessment will be used to provide long-term services and supports benefits to Washington State residents who have paid into the LTSS Program for a specific amount of time and who need a certain amount of assistance with activities of daily living.

Employees' have a one-time opportunity to opt-out if they have comparable private long-term care insurance that meets the qualifications and was purchased before November 1, 2021.
