
Shop Steward Committee Monthly Workshops

Shop Steward Highlight: Dorinda Gardner

Dorinda Gardner has been a Periop Materials Specialist at Samaritan Hospital in Moses Lake for 17 years and a Shop Steward for 12 of them. The last 16 months have been especially challenging for her and her coworkers at Samaritan. On top of the pandemic, they have been in a contract fight with their employer, who came in with countless proposals to diminish current benefits. But not one to back down from a challenge, Dorinda and her fellow Bargaining Team members got to organizing and advocating. And it's no small feat that in April they ratified an agreement



that included cost of living increases for all employees, market adjustments for underpaid classifications, additional steps on the salary schedule, and maintenance of benefits that were previously on the chopping block.

"I like being a Shop Steward to help those who may need some support during a very difficult time. I like collaborating with Human Resources to come up with a mutual plan for the employee and the facility," Dorinda said, "Being part of the negotiation team I find very challenging which suits my personality. Although negotiations can be strenuous it is worth the challenge and success that can come out of them."

Did you Know? Washington Paid Family Medical Leave

Washington State now has Paid Family and Medical Leave (PFML) which provides eligible workers paid time off when you have a serious health condition that prevents you from working, when you need time to care for a family member with a serious health condition, birth or placement of a new child or for certain military-related events. You must have worked 820 hours in Washington state over the last year to be eligible. When you take Paid Leave, you can receive up to 90% of your weekly pay—up to a maximum of \$1,206 a week in 2021. The amount of time you can take depends on the situation. The paid leave time can be taken intermittently (in 8-hour increments), or all at once. PFML and FMLA have different eligibility requirements and offer different protections, and in some situations, you may want to take both.
