Notice of 2022 OPEIU Local 8 Nominations and Elections

In accordance with Article 14 of Local 8's Bylaws, this is formal notification that nominations and elections will take place at the January 22, 2022 Membership Assembly. The Local 8 Constitution and Bylaws, which describes the duties and responsibilities for each position, can be found on the Local 8 website at www.opeiu8.org under "About Us." You can also call the Local 8 office at 1-800-600-2433 to request a copy. The Bylaws explain in detail the election process. Here are the open positions:

- Nominations and election of an Election Committee of seven (7) members and seven (7) alternates to serve a three-year term
- Nominations and election of all vacant Central Labor Council positions to serve a one-year term
- Nominations and election of two (2) Trustees to serve a three-year term
- Nominations for Business Manager, President, Vice-President, Secretary-Treasurer, Recording Secretary and twenty-one (21) Regional Executive Board Members and twenty-one (21) alternates to serve a three-year term

The twenty-one (21) Regional Executive Board Members shall be nominated and elected only by those members who reside in the same region as the Regional Executive Board Member nominees. The President, Vice-President, Business Manager, Secretary-Treasurer, Recording Secretary and Trustees are

at-large positions and voted on by the entire Local 8 Membership. The four Regions and how the 21 positions are distributed are as follows in accordance with the formula defined in Section 1(c) of Article 14 of the Local 8 Constitution and Bylaws.

NORTH REGION: Whatcom, Skagit, Snohomish, San Juan and Island Counties shall nominate and elect four (4)

CENTRAL REGION: Martin Luther King Jr. County shall nominate and elect seven (7)

SOUTH/WEST: Clallam, Jefferson, Kitsap, Mason, Grays Harbor, Thurston, Pierce, Pacific, Lewis, Cowlitz, Wahkiakum, Clark and Skamania Counties shall nominate and elect six (6)

EAST REGION: All other Washington State counties shall nominate and elect four (4)

Members who reside outside of Washington State shall be included in the four (4) Regions as follows: Members who reside in Hood River County, Oregon and all Oregon counties west shall be part of the South/West Region. Members who reside in Oregon counties east of Hood River County, Idaho and all other states shall be part of the East Region.

ELIGIBILITY: Members must be in continuous good standing for at least twelve (12) months prior to an election for any Officer or Trustee position. Members must be in continuous good standing for at least six (6) months prior to serving in a delegate position.

NOMINATION PROCESS: Nominees must be in attendance at the Membership Assembly on January 22 or declare in writing their willingness to accept the nomination. Written declaration must be provided before the close of nominations and must be in the form of a hard copy email or other written material that clearly

Cornish & Forterra Workers Vote to Join Local 8

On December 1st the staff at **Cornish College of the Arts** voted overwhelmingly to form their union with OPEIU Local 8. Their election result has been hard-fought after multiple delays due to a hearing and appeal to the National Labor Relations Board (NLRB) by their employer since they filed for their vote in May 2021.





The group of 42 student support, administrative, IT and facilities staff in Seattle are dedicated to supporting Cornish's mission of providing a quality arts-based undergraduate education. They sought to unionize to improve working conditions, increase transparency and have a chance to participate in decision-making that directly impacts the lives of staff and students. "I am so proud of the work that has gone into securing our victory today," says Department Coordinator Rachel Brinn. "This will empower the staff to continue to do the important work of fulfilling Cornish's mission to its students and the community."

Just a week later on December 8, votes were counted for local environmental nonprofit **Forterra NW**'s union election, and they too elected overwhelmingly to join OPEIU Local 8. "I'm excited for all we will be able to do for Forterra staff members and our community now that our union is in place," said Maya Klem, Green Cities

Project Manager. "Thanks to all of you who have been a part of organizing our union — this is a huge win for all of us!"

Originating as a land conservancy in 1989, Forterra NW today works around Washington State to create a more sustainable future through conservation, restoration, community-based partnerships and innovation. Local 8 represents members at many nonprofit organizations, but Forterra is the first to join with an environmental focus.

identifies the nominee and includes a date. Text messages from an electronic device will not be accepted. Self-nominations are allowed. Nominations do not need a second.

ELECTION: Elections for Delegate and Election Board positions will take place at the January 22 Membership Assembly. The election process for Officers and Regional Executive Board Members will be by mail ballot in accordance with the OPEIU Local 8 Election Policies and Procedures and with the Local 8 Constitution and Bylaws. Both documents are available on the Local 8 website (www.opeiu8.org) or by contacting the Local 8 office at 1-800-600-2433 ext. 101. Ballots will be tallied for the General Election on Monday, February 28, at a time decided by the Election Committee.
