# Hazard Pay to Continue through December 31, 2020!

Coastal Community Action Program received additional temporary Hazard Pay from the State that will be in effect from October 1, 2020 through December 31, 2020. This continuation will be at the previous rate of \$2.49 per hour for every hour actually worked. This increase will not apply to any non-worked paid hours such as Paid Time Off (PTO), Bereavement Leave or any other paid leave. Hazard Pay of \$2.49 per hour will continue for all hours worked through December 31, 2020.

## **Immediate Action Needed**

OPEIU Local 8 along with The Long-Term Care Coalition is calling on Governor Inslee to reject the proposed budget cuts to Long Term Care in Washington State, that would drastically eliminate critical services that provide assistance with daily activities like eating, bathing, and taking medications. To contact the governor <u>click here</u> and urge him to protect our most vulnerable populations by preserving our budget for long-term care services.
