Hazard Pay to Continue through December 31, 2020!

Senior Life Resources received additional temporary Hazard Pay from the state that will be in effect from October 1, 2020 through December 31, 2020. This is a continuation at the previous rate of \$2.36 per hour for every hour actually worked. This increase will not apply to any non-worked paid hours such as Paid Time Off (PTO), Bereavement Leave or any other paid leave. This Hazard Pay of \$2.36 per hour will continue for all hours worked through December 31, 2020. In addition to this increase you will also be eligible for an additional \$3.00 an hour for any hours worked caring for a client who is Covid-19 positive.

¡Pago de riesgo continuará hasta el 31 diciembre de 2020!

Senior Life Resources recibió el pago de riesgo adicional temporalmente del estado que estará vigente desde el 1 de octubre de 2020 hasta el 31 de diciembre de 2020. Este monto de pago de riesgo del estado es una continuación a la cantidad anterior de \$2.36 por hora por cada hora realmente trabajada. Este aumento no se aplicará a las horas pagadas no trabajadas, como el tiempo libre pagado (PTO, la licencia por duelo y cualquier otra licencia pagada). Este pago de riesgo de \$ 2.36 por hora continuará en todas las horas trabajadas hasta el 31 de diciembre de 2020. Además de este aumento, también será eligible para \$3.00 adicionales por hora por las horas trabajadas cuidando a un cliente que es positivo para COVID-19.
