## **Bargaining Update**

We went back to the bargaining table to meet with management on February 19th and 27th, to continue working on improvements to our contract. Our team has been working hard and we have reached several tentative agreements which include:

- the right to bargain changes to our health and dental insurance
- a clear process if a paycheck is not properly issued
- improved language around meal and rest break language
- no denials for employees requesting PTO for medical/dental appointments with advanced notice

Our team is still working on wages and other economic proposals which we will be presenting to management over the next few bargaining sessions.

Our next bargaining session is on March 12th to continue working for real improvements to our contract.
