Be a Champion! Help Local 8 Members in Need

The OPEIU Local 8 Hardship Fund was established in 2011. We are the only OPEIU local in the nation with a fund to help its union members in need. Since the fund was created, it has issued more than 200 awards to members in need who have suffered an emergency or catastrophe, such as a fire, a death in the family, or a loss of work income due to their own or a dependent's serious health condition.

Originally seeded by our International and Local 8, the Hardship Fund is now solely financed through Assembly fundraisers and the individual contributions of Local 8 members. Regrettably, the need is greater than the donations received from the 30 individuals who have made financial contributions to the fund this year. Our Hardship Fund is currently at a critically low balance.

Local 8 continues to negotiate in its union contracts the option for members to donate to the fund through payroll deduction by their employers. To find out if you are able to give via payroll deduction, check your contract and fill out the Payroll Deduction Authorization form, which can be found on the "Hardship Fund and Resources" page under "Member Support & Action" on the Local 8 website and then send it back to the Union. Our office will process the paperwork.

Another way to donate to the Hardship Fund is directly through your own checking account. Why not sign up for automatic bill pay on a monthly basis to support the fund? Authorize a check made payable to the "OPEIU Local 8 Hardship Fund," at an amount which fits your budget, to be mailed to: 2800 First Ave #304, Seattle, WA, 98121.

If you prefer to help your Local 8 sisters and brothers in need through a one-time donation, that would be wonderful as well! Please send contributions via check or money order, made payable to the "OPEIU Local 8 Hardship Fund," to the above address.

Please note that at this time donations to the Hardship Fund are *not* tax deductible, although we hope to change this in the near future.
