Expedited Bargaining

OPEIU Local 8 members at Providence Everett have worked nonstop throughout this ongoing pandemic. We've seen many leave the healthcare profession or seek work elsewhere, sometimes for higher pay, which has resulted in a staffing crisis. Recently, Providence management reached out to our Union with a proposal to begin "expedited bargaining" months before our contract expires. Our Professional and Technical coworkers who are members of UFCW 21 recently completed expedited bargaining and have been pleased with the result. OPEIU member leaders are recommending this process, with the idea that we could bargain wage increases now, rather than wait until our contract expires in October.

To ensure our voices are heard and our Union Contract reflects our priorities, we need your participation. Please participate in our Bargaining Survey.

Survey information collected will be used to develop contract bargaining proposals. Individual survey responses will be kept confidential.

Please note that we will be limited in the number of contract Articles we will be opening and fewer Bargaining Team members in this expedited bargaining process. The idea of expedited bargaining is to use a leaner process to get economic and wage increase priorities settled and implemented quickly. However, we also want to hear your other contract priorities so your Bargaining Team knows what is most important to you.
