## **Expedited Bargaining update**

Our Bargaining Team has been working hard formulating and presenting proposals in this expedited process. We met with management on April 13 for our first all-day session. We exchanged bargaining proposals, and have reached tentative agreements on some non-economic items.

Then on April 15 in our second all-day session, management presented their economic proposals. Our team had presented a fair across-the-board increase that would help all in our Union in this time of inflation and economic uncertainty. We also traded proposals on premiums and differentials, as well as market rate adjustments and bonuses. We have made some good progress, and the Bargaining Team is hopeful we will eventually reach an overall agreement that we can recommend to all.

We are scheduled to meet on April 28 for another all-day meeting with our focus on our members' priorities of wage increases.

Reach out and let the Bargaining Team members know you are standing with them in support of their hard work at the bargaining table. It's important that we all stay united during these negotiations!
