# Our Union Healthcare Benefits Committee is Recommending a YES Vote!

OPEIU 8, SEIU 1199NW, IUOE 302 and management have reached a recommended agreement through the Healthcare Benefits Committee for a new benefits plan for all eligible employees beginning in 2022. Changes to the healthcare benefits for 2022 include:

- Maintain current premium costs for My Valley and Choice plans participants who complete Wellness program point requirements for premium discounts.
- Small increase (2%) to My Valley and Choice plans for participants who do not complete Wellness program points requirements.
- My Valley Medical Plan includes zero out-of-pocket maximum requirement for Tier one services.
- Choice Medical Plan Tiers and out-of-pocket maximums remain unchanged.
- Both plans have maintained zero monthly premiums for Employee-only coverage. (Employee must participate and earn the required Wellness points to achieve the zero premium.)
- NEW Vitality Wellness Plan begins January 1, 2022.
