#### **Our Union Contract**

We are heading into the second year of our current Union Contract, where you received a 2.75% increase January 1, 2022. A new step for year 19 was added to the wage scale, so those of you above year 18 benefited from this additional step being added to the contract. We want to make sure that new employees know that you will also receive an annual step increase on your anniversary date of hire. Our wage scale will increase an additional 2.75% on Jan. 1, 2023.

Our July 1, 2020 – July 1, 2023 Union contract also brought improvements such as new Training Pay of \$1 an hour for workers being assigned to train an employee on departmental process and procedures, equipment, programs and/or to check off knowledge per departmental job manual. We have enjoyed increases to our Differentials and Weekend Premium Pay, along with an increase in the Employer Contribution to the retirement plan, and we can now use our Extended Illness Bank to care for a grandchild.

# Personal Protection Equipment, PPE, Bimonthly Meetings Continue

Washington hospitals are required to meet bimonthly with the Union to review current PPE supplies, projected PPE burn rates, and report any concerns the hospital is having meeting the demand of necessary PPE supplies along with their plan to address any concerns they have. In our bimonthly meetings the hospital has been reporting they have been able to consistently keep up with the demand of the necessary PPE supplies. Shop Steward *Karisa Makaiwi Hodel* and Union Representative *Shelby Mooney* have been attending these meetings.
