## **Shop Steward Spotlight: Anna Anderson**

Anna Anderson is the Lead Coder at Willapa Harbor Hospital. She has been a steward for seven of her eight years at the hospital. As a new union member, Anna really appreciated the support of the union steward, John Latimer, who became her mentor. Anna assumed the role and responsibilities of Shop Steward, serving the needs of Willapa Harbor Hospital employees with dedication and compassion.



Anna states her passion and commitment best, "Because I learned so much about our union contract and our union rights from John, I wanted to be a steward to welcome new members into OPEIU, Local 8. The new member orientation is so important. I welcome them to the hospital in my office and review the union new membership packet with them to ensure they know their contract and their union rights. I want my coworkers to understand how important the union is in supporting our career goals and our day-to-day on-the-job experiences. I explain to the new employees the importance of a strong contract and that we have that because we have a strong union presence because of the high percentage of union membership and without a strong union presence our contract wouldn't be as strong." We are lucky to have such a strong advocate for our employee and union needs.

### The Importance of Politics and Labor

The goal of the OPEIU Local 8 Political Action Committee (OPAL) is to ensure we are supporting candidates that have a proven track record of advancing pro-worker legislation. OPAL is focused on issues that affect OPEIU 8 members and contributes to candidates for state and local offices throughout Washington. Unions have achieved great gains for workers through political action including:

- Washington Sick and Safe Leave which provides workers with job protection
  when they use their accrued WA sick leave time ensuring we can focus on
  getting well without worrying about discipline at work.
- Washington Paid Family Medical Leave is a mandatory statewide program which provides paid time off for a worker with their own serious illness or to care for an immediate family member's serious illness. This leave also ensures we can focus on getting well or caring for our family members, while we can still pay our bills and feed our families.

"Union power is political action. OPAL is committed to organizing, mobilizing and educating our membership on the issues and the candidates," Sara Franklin, OPAL Chairperson, OPEIU 8 Executive Board Member and activist.

Together, our contributions to OPAL make a significant difference because they support our union's ability to educate candidates about the issues that matter most to workers and our families. Any Local 8 member in good standing may participate in OPAL. Committee members make a minimum contribution of \$60 per year or \$5 per month; no dues money goes into OPAL. ## **Bargaining Win for OPEIU Members at Providence!**

OPEIU Local 8 members at Providence Regional Medical Center Everett overwhelmingly ratified a new three-year agreement on May 13th. This new contract provides for a minimum 10% increase over three years; however many members will receive much more due to adding steps to the scale and market adjustments for most of the direct patient care jobs. For example, CNAs and Health Unit Coordinators received a minimum 10.5% increase the first full pay period following ratification! There are also bonuses of \$1,000 in years one and two of this Agreement.
