Reminder – Samaritan Bargaining Unit Meeting

The bargaining team will be hosting a bargaining unit meeting on **June 8th at 6 pm in Room 407**. Come join us and ask questions about bargaining. Dinner will be provided!

Our bargaining team met with management to continue negotiating our new contract and wage increases on **Thursday May 25, 2023**. Management responded to some, but not all, of our initial proposals.

We have made significant progress in the following areas:

- Employees being able to transfer or take a promotion when you have a discipline on your file;
- Coaching for probationary employees;
- Employees being able to use PTO or Leave Without Pay when assigned low census.

There has been some movement on interpreter pay and our bargaining team will continue to push management to ensure a policy that works for all.

Our bargaining team continues to stress to management that certain policies are in place to create equity across Samaritan but that they are not being applied equitably. Our bargaining team shared how this impacts being able to retain employees at Samaritan.

We will meet again with management on **June 8th and 9th**.
