Union Update

Staff Reduction

On Tuesday January 3rd, during the KPWA Town Hall meeting, leadership discussed that Washington Region has experienced a reduction in membership leading to a loss of revenue. Without engaging in partnership, KPWA announced a possible reduction in positions in several work units. OPEIU Local 8 invoked our contract language regarding Initiatives and demanded that KPWA bargain the decision to reduce positions and the impacts. While KPWA would like to have the reduction go into effect by the end of March, they have yet to provide the information we requested and engage in bargaining.

Under the National Agreement, the Performance Sharing Program has changed significantly. For 2024, the goals were negotiated in the National Agreement and provide for a payout regardless of whether or not the region meets its financial goal.

For 2023, the National Agreement set a payout of \$1,500 for all eligible employees. This payout should be paid out in March of 2024. If you do not see this payout in your March pay statements, please contact your Union Representative.
