# Workers at Disability Rights Washington Win Voluntary Recognition

In July of this year, Employees at Disability Rights Washington (DRW) won voluntary recognition with OPEIU Local 8 after demonstrating unanimous support for unionizing. The group of 24 staff attorneys, investigators, ombudspersons, advocates, and educators are dedicated to advancing the dignity, equality, and self-determination of people with disabilities. They sought to unionize to have a voice in their workplace and have an active and collaborative role in stewarding their organization's work as they work towards greater alignment with disability justice values.

While their name and structure has evolved over its 50+ history, their dedication and mission has remained the same, to protect and advocate for the civil and human rights for people with disabilities. Whether through grassroots leadership development, litigation, public policy, self-advocacy, or systemic reforms, DRW is the sole advocacy organization in Washington State fighting for disability justice. "Our commitment to the disability justice movement requires us to take an active and collaborative role in stewarding not only our organization's work but also our own workplace's culture and practices towards ever greater alignment with disability justice values. Unionizing is one piece of how we can engage with this responsibility" shares attorney, Danny Waxwing.

Our delegation proudly presented our Organized Workers for Labor Solidarity (OWLS) statement on Solidarity with Gaza resolution at the Convention, a significant initiative that received overwhelming support during our January Membership Assembly this year. Considering another resolution being introduced, several members of OPEIU's delegation seized the opportunity to collaborate in an ad hoc committee. Together, they worked diligently to merge the proposed resolutions into a unified and impactful statement, showcasing our commitment solidarity. Benjamin Peterson, executive board member shares of his experience, "If member leaders in our Local hadn't laid the groundwork for this resolution through months of our own internal deliberations, and if we hadn't brought forward our own resolution to jump start discussions at the WSLC, this issue would have never made it to the WSLC's floor."

Annaliza Torres, delegate and member leader added, "...I was impressed that we had subject matter experts and was moved by their passion, compassion and determination to stand against genocide and fight for Palestinian lives. With leadership from our Local Union delegates, everyone interested was able to participate and have a voice in drafting the best resolution we could in solidarity with Gaza."
