## Flores Siblings Gain New Perspectives at Union Summer Camp

This past summer, 16-year-old Jack and 13-year-old Emma, children of Local 8 members Emmanuel and Amanda Flores, had the opportunity to attend a union summer camp at The Vines Center in Little Rock, Arkansas, thanks to OPEIU's Romeo Corbeil/Gilles Beauregard Scholarship Fund. In addition to traditional summer camp activities, Jack and Emma were able to learn more about labor and civil rights history.

On her camp experience, Emma shared, "My favorite part was visiting the Little Rock Nine Museum and learning about the challenges they faced every day just to get an education and how they changed history." Emma also reflected on how she learned to push herself outside her comfort zone, stating "I met new people, became more independent, shared new experiences, and tried different challenges."

Reflecting on his time at camp, Jack shared, "I learned about how different cultures have shaped labor practices throughout history, but I also learned how hard women and minorities had to work to gain the same rights in the workplace." Jack discovered a new passion for public speaking, indicating "The workshops really helped build my confidence, and I'm excited to use these skills in the future." Jack enthusiastically added "I would recommend union summer camp 1,000% to other kids! You not only make new friends, but also learn about essential topics like workers' rights, teamwork, and leadership. Plus, the balance between fun and learning is perfect."

At the Local 8 membership assembly in September, Jack and Emma took the stage to share their experiences from the union summer camp, delivering powerful and inspiring speeches. Their reflections resonated with the audience, underscoring the camp's lasting impact in teaching young people about the history and principles of the labor movement. In a touching gesture, they presented flowers to Local 8 Representative Tara Powell, who told their family about the camp, as well as Local 8 Business Manager Suzanne Mode and President Kellie McGuire for their support.

This experience reminds us all of the importance to invest in and nurture future generations in the fight for workers' rights!

## First in the Nation OPEIU Hardship Fund Thriving

In August 2010, OPEIU Local 8 established the first ever Hardship Fund within our International Union. Since then, we have distributed over \$111,500 in assistance to members in need. This year alone, over \$5,000 has been distributed to 22 members. At our September Membership Assembly this year, the Hardship Fund Raising Committee held a bake sale. With your contributions through baked goods, purchases and one-time donations we raised nearly \$800! That sum doesn't include new monthly contributions from the 10 people who signed up for payroll deduction at the event! With your help, we were able to increase the amount of financial assistance the Hardship Fund Committee can provide from \$250 to \$350. Our Hardship Fund is one of the many ways OPEIU Local 8 puts the concept of solidarity into action.
